Report it to an adult, parent, sheriff, police officer, school resource officer, school staff member immediately.

RECEIVING nude or semi-nude pictures is **NOT** a crime.
KEEPING them and **SENDING** them is a **CRIME!**

What is Sexting? Sending nude or semi-nude photos of themselves to friends, boyfriends or girlfriends who sometimes send them to other classmates who can then send them to anyone.

- ◆ 45% of teens have cell phones
- ◆ 75% of teens use IM (Instant Messaging)
- ◆ 48% of teens use IM (Instant Messaging) daily
- ◆ 1 in 5 teens stated they have texted nude or semi-nude pictures of themselves
- ◆ 11% of girls (13-16) have texted nude or semi-nude pictures of themselves
- ◆ 18% of teen boys have sent nude or semi-nude photos via cell phone
- ◆ 44% of teen boys say they have seen a nude photo of a female classmate
- ◆ 1/3 of teen boys and 1/4 of teen girls stated they have received nude photos that were originally intended to be private
- ◆ 39% of students (13-19) are sending/posting sexually suggestive messages over text or email
- ◆ Of that 38%-50% said the messages include nude photos of themselves

Regardless of the situation it is illegal to possess, distribute, or manufacture semi-nude/ nude pictures (sexually exploitive material) of anyone less than 18 years of age.

"SEXTING" AND THE LAW

There are a few state laws that apply to "Sexting". The following is a summary of those laws.

Sexual Exploitation of Children.

Any person, for any purpose, who knowingly makes, publishes, promotes, distributes, sells, offers, exhibits, possesses, or controls any sexually exploitive material (legal definition for child pornography) by any means (to include digital or electronic) is guilty of this crime. Distribution or production is a Class 3 felony and possession is either a class 4 or class 6 felony depending on the amount possessed.

Promotion of Obscenity to a minor.

A person commits promotion of obscenity to a minor if, knowing the content, they promote, or possess, with intent to promote to a minor, any obscene material. This is a class 6 felony.

Unlawful Sexual Contact

Any person who knowingly observes or takes a photograph of another person's intimate parts without that person's consent, in a situation where the person observed has a reasonable expectation of privacy commits unlawful sexual contact.

Anyone convicted of the crimes listed above is subject to becoming a registered sex offender with your name and address listed on both the **local and national sex offenders' registry** and sex offender treatment for several years.

"A nude image loose in cyberspace can torpedo a college application or job search. Worse, it can end up in the hands of a sexual predator. ... Teens in several states have been charged with felonies — including sexual abuse of a minor and distributing or possessing child pornography — or sexting. In many cases, a conviction comes with a mandatory, lifelong listing on a sex offender registry." (Chicago Tribune 2009)

Sexting victims experience feelings which are humiliating and degrading due to something that was meant to be private being publicized; in some cases resulting in suicide.

 - ◆ The military?
 - ◆ College?
 - ◆ Local or federal law enforcement?
- ◆ Probability of keeping your sports/academic scholarships?
- ◆ Probability of getting your dream job or accepted to your dream college as a registered sex offender?
